Which material should be quoted? Plastic Laminate is not recommended for wet areas.

The Toilet Accessory Schedule is correct. The project intends to call for (K&L) to be Bobrick Solid Color Reinforced Composite (Phenolic).

The toilet partitions and urinal screen shall be a basis of design the Bobrick SierraSeries SCRC (Solid Phenolic) 1090 series. Color to be selected by Owner / Architect - The drawings and specifications will be revised and included in the forthcoming Addendum #02 document package.

Existing plan sets show these to be 9' in depth. Structural Engineer notes that bottom of footings supporting the entry gateway are -3'-10" below FFE. Existing footings are spread foundations.

Can the existing concrete that is being removed/demolished be crushed and reused, at least in part, as the 304 aggregate base?

Does the metal fabricator need to be AISC certified for this project? In lieu of being AISC certified, can we have 100% visual inspection of all welds performed by a CWI? We are AISC compliant (mill test report tracking, weld tracking, quality management program) and will provide all the necessary information related to the quality management program.

Α.

While the project specifications currently require work to be performed by an AISC Certified Welder, the Owner is open to considering alternative qualifications. Bidders who are AISC compliant but not certified may still submit proposals. If awarded the project, such bidders must be prepared to demonstrate equivalent quality control measures, including but not limited to:

100% visual inspection of all welds performed by a Certified Welding Inspector (CWI), Comprehensive mill test report tracking, Weld tracking documentation, A formalized quality management program, or more. The project will be required to adhere to Ohio Building Code, specifically for this question Chapter 17, (1705.2), and the Special inspection matrix on Sheet S003.

Please note that any modifications to the original project specifications, including alternative qualifications, may necessitate additional testing, review, or approvals. Any such adjustments will be determined at the Owner's discretion and will be the responsibility of the selected contractor, including any additional associated costs. We encourage all interested bidders to submit their proposals, understanding that final requirements will be confirmed during contract negotiations.

Note 10 on sheet C130 is in reference to bollards, found in the dumpster pad area, near the mechanical/pump room. Note 9 does appear to be misidentified on the sheet. The columns near the entrance/proposed building should be included with note 6, instead of note 9.

Is it assumed that the only MEP items to be painted are located in finished areas? The Interior Painting Spec calls for the MEP items to be painted in the equipment rooms as well per section 3.3 E.

Α.

Yes, thank you for that clarification. MEP Items should be painted only in finished locations. This requirement does not apply for MEP for Pump House and Pump House Expansion, and Slide Pump House area or other non-finished area.

Q.

With regard to the ceiling-hung toilet partitions and changing panels, how are these to be supported? There is nothing referenced in the structural plans.

Α.

The Manufacturer and GC should provide the mounting structure - that could be a steel channel hung from the ceiling with threaded rods, unistrut with threaded rod, or another method. Means and methods is up to the GC. Owner requests these be ceiling mounted or a top mounted units with a span structure between walls.
